Flamenco Vivo Studio Renter COVID-19 Vaccination Policy

Updated December 14, 2021

In accordance with the [Key to NYC](#) requirements and to ensure the continued health and safety of our staff and community members, **effective September 13, 2021, all individuals visiting Flamenco Vivo Studios age 5 and older* will be required to show proof they have received at least one dose of an approved COVID-19 vaccine. Starting December 27, people 12 and older participating in public indoor activities will be required to show proof they have received two vaccine doses, except for those who have received the one dose of the Johnson & Johnson vaccine.**

For proof of vaccination, you can show:

- [CDC Vaccination Card](#). A photo or photocopy of this card is also acceptable.
- [NYC Vaccination Record](#) or other official immunization record from within or outside the U.S., including from your health care provider. A photo or photocopy of this card is also acceptable. If you are unable to get this record, **call 311**.
- **NYC COVID Safe App**: [Android](#) | [iOS](#). You can upload to this app a photo of your CDC vaccination card or other official record, along with your photo ID.
- [Excelsior Pass](#) (or Excelsior Pass Plus). To use this app, you will need the phone number or email address associated with your NYC vaccination record. If you are unable to use this app, try one of the other options listed above.

Flamenco Vivo will keep any medical and personal information obtained in connection with this vaccine verification confidential in accordance with, and to the extent required by, applicable law, regulations, and guidance.

*Visitors under 5 years of age must wear a mask at all times at Flamenco Vivo Studios.

Protocol for Rehearsals and Private/Semi-Private Classes:

1. Renters who will be conducting rehearsals or private/semi-private classes must submit their proof of vaccination ahead of time via the Vaccination Confirmation form: https://spanishdanceartscompany.formstack.com/forms/fvcs_studiorenter_vaccination_confirmation
2. If there are other individuals joining you in the studio, you must submit their names and email addresses when you make your rental request online. They will receive an email with the Vaccination Confirmation form. There is space to submit up to 5 individuals. If there are more than 5 people joining you in the studio, please email their names and email addresses to studio@flamenco-vivo.org.

Protocol for Group Classes:

1. Teachers who will be conducting group classes must submit their proof of vaccination ahead of time via the Vaccination Confirmation form:

2. We understand that it is not always possible to know ahead of time who will attend a group class. Therefore, you will be responsible for checking for proof of vaccination of all students who attend your class.
3. You do not need to keep a copy of the vaccination record. Simply verify that they have valid proof of documentation of receiving at least 1 dose of a COVID-19 vaccine. Starting December 27, 2021, all students age 12 and older must show proof of full vaccination.
4. If a student is unable or unwilling to show documentation, they are not permitted to join your class.
